Consultation on proposed changes to the Council's Enforcement Policy

Cheshire West and Chester Borough Council wish to invite your views and the views of young people on changes we are considering to the Council's Enforcement Policy.

The Policy sets out the Council's general approach to enforcement so that residents, businesses and visitors to the Borough know what to expect, and how the Council responds to non-compliance.

We are proposing to update the Enforcement Policy to reflect current legislation, guidance and best practice. Most of the areas for revision follow statutory legislation and guidance and do not require public consultation however, there are two key issues of which the Council has discretion, but would like to seek residents' views in order to balance effective service delivery and the needs of the local community.

We are particularly interested in understanding views on:

- Issuing Fixed Penalty Notices (FPNs) to juveniles as a means of dealing with low level offences such as dog fouling and littering, as an alternative to prosecution or simple caution. (This will be a last stop measure) and;
- Introducing targeted, non-uniformed enforcement operations in areas where dog fouling and littering have been reported by residents as problematic.
